## DIRECT DEPOSIT – WIRE TRANSFER INSTRUCTIONS

### DBH Law in Trust is a SCOTIABANK Account

Please note certified funds are required for deposit of funds via wire transfer or direct deposit.

Please provide us with a copy of the bank deposit confirmation once it has been completed.

1. The purchaser must take a **BANK DRAFT** made payable to **DBH LAW in trust** to Scotiabank. No personal cheques. Please note – we require a copy of the **BANK DRAFT** to accompany the deposit slip (if the purchaser is transferring the deposit directly from a CIBC account, we do require a copy of a **BANK DRAFT** or **CERTIFIED CHEQUE**)
2. Attached VOID Cheque (page 2) is required for all Bank Drafts.
3. Take a copy of the void cheque along with your bank draft to SCOTIABANK and ask for direct deposit.
4. You will receive a **deposit slip** which you **must scan to [info@metroside.ca](mailto:info@metroside.ca)** so we can correctly allocate the funds.
5. Purchaser(s) names and unit number must be noted on all receipts.
6. **All wire transfers require an additional \$15 fee added to the deposit.**
